What is the Equality and Human Rights Commission?



The Equality and Human Rights Commission works to make sure that people are treated fairly and equally.

We are working to stop **discrimination** against disabled people, men and women and people from different races and cultures.

Discrimination

This means treating someone worse than other people for some reason.

We are also working to make sure that people of different ages, **lesbian** and **gay** people and people from different religions are treated fairly and equally.

Lesbian and gay

Lesbian means a woman who is attracted to other women. **Gay** means a man who is attracted to other men.

We also want to make sure that people's **human rights** are respected.

Human rights

Basic rights and freedoms that belong to every person in the world.

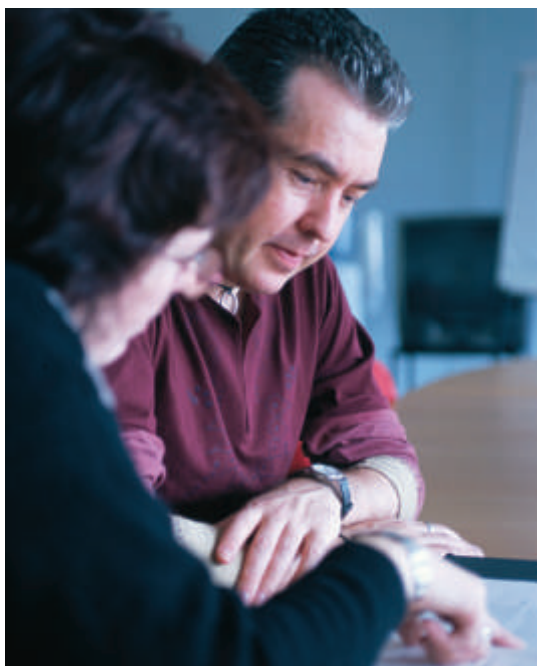
What does the law say?

The law says that if you are a **student** and you are disabled, you should

- be treated the same as anyone else
- have the same choices as anyone else.

Student

This means if you are learning at a college.



Does the law matter to you?

The law matters to you if you are

1. Over 16 years old
2. A student, or you are thinking of becoming a student



3. You have a disability. For example, a learning disability.

How does the law help?

The law helps you when you are a student in a classroom. The law says that you must be treated the same as everyone else.

The law also helps you when you are:

- trying to become a student
- using the student library



- going on a trip your college has organised
- doing sport
- in the canteen
- in student housing.

Examples of discrimination

These are examples of **discrimination**.
They are against the law.

Discrimination

This means treating someone worse than other people for some reason.

Discrimination because of a disability

Example: You are told that you cannot go to college because the college does not take people with learning disabilities.

Example: A student uses a walking stick. He is told he cannot go on a walking trip because he would walk too slowly.

Discrimination by not doing things to help disabled people

Example: A student with a learning disability is told she cannot use a support worker.

Example: A deaf student is told he cannot have a **signer** in the classroom.

Signer

This is a person who uses their hands to talk to a deaf person. This is called using sign language.



Being fair

The law says that the college has to make changes to help you study. This means doing what is fair.

Any changes need to be fair to you. They also need to be fair to the college.

Should I tell my college about my disability?

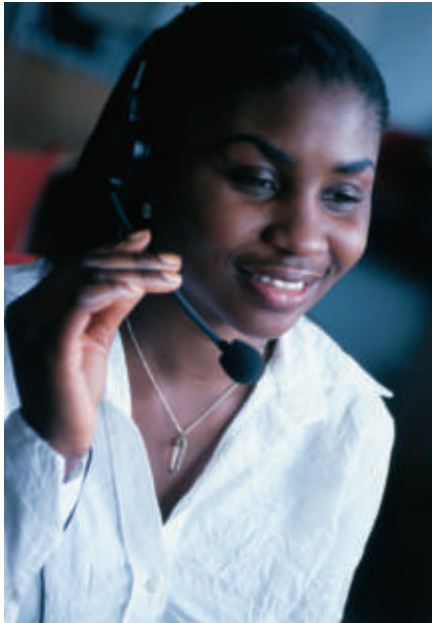
Yes, this is the best thing to do.

Then they should make sure that you are treated fairly.

You can ask them not to tell anyone else about your disability.

What can I do if I think I am being treated unfairly?

If you feel you have been treated unfairly, you can talk to your support worker.

You can also ask the college about their **complaints procedure**.

Complaints procedure

This is a way you can tell people how you have been treated unfairly.

If this does not work you may want to go to court. The judge will decide what to do next.

You need to complain to the court within six months of the time when you were treated unfairly.
